**** If payment and registration form are not received by October 20th, the booth will be resold.

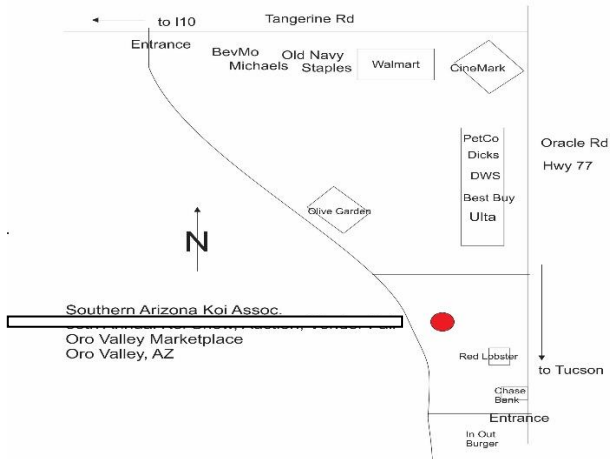
